SCARLET & GOLD RIDING CLUB Stables Rule and Regulations

It is the desire of the Club our facility be a safe and fun place for our members and their guests. Please familiarize yourself with the following rules and regulations and abide by them.

- 1. The members are responsible for the conduct of family members and guests at all times.
- 2. Do not feed or handle another member's horses without permission from the owner.
- 3. Privately owned vehicles (POV) will be allowed inside the stable gates for dropping off feed, heavy tack, etc., or for hooking up horse trailers. POVs are not to be parked inside the fence, driven down the lanes, into any turnout, isolations, sick paddocks or quarantine without permission from the Executive Board. Should the first outside parking lot be full, parking will only be permitted on the front side of barn 1. Should a member be transporting a horse(s) to or from the SGRC facility, the POV can be connected to a trailer while caring for horses that are being or have been transported. No riding, training or caring for other horses until the POV is moved back to the parking area. PLEASE MAINTAIN A SAFE SPEED AND LIMIT VEHICLE TRIPS INSIDE THE GATES FOR THE SAFETY OF ALL CONCERNED.
- 4. Dogs are allowed on the property. Must be leashed, well behaved and within 8 ft. of the owner at all times. Prohibited dog breeds are not allowed. All dogs must be able to pass an AKC Good Citizen Test. Only personally owned dogs of members can be brought. All members are responsible for all dog droppings. At any point, a dog may be asked to leave. It's up to the discretion of the Executive Board. Appropriate numbers of barn cats are allowed to keep the rodent population under control.
- 5. Any drinking of alcoholic beverages shall be done when the Executive Board announces that it is permitted at SGRC functions. If you have consumed too many beverages, you may not handle or ride a horse. No public intoxication on stable grounds.
- 6. Smoking of traditional cigarettes, cigars, or e-cigarettes is permitted on the property of the Scarlet and Gold Riding Club. No smoking of any kind traditional or e-cigarettes is permitted inside any structure on the property, or within 50 ft. of structures. All waste ie. cigarette butts, jewel pods are to be disposed of properly and not thrown on the ground.
- 7. Parents or guardians are responsible for cleaning up after their children. Children under the age of 7 must be under the direct supervision of a member not less than 16 years of age. Direct supervision is described as: immediate intervention is possible if a problemoccurs.

- 8. No one is permitted in The Club Office, Maintenance Office, Hay Barn or Shavings Bin unless escorted by an Executive Board Member.
- 9. All riders must wear approved helmets while jumping a horse. Parents or guardians are responsible for the safety of minors.
- 10. All horses must be ridden at a walk outside of the riding arenas. Riding is not permitted inside any structures or turnouts.
- 11. Horses cannot be lunged outside of the riding arenas unless under the care of a Veterinarian or other equine professional.
- 12. Horses will not be allowed to run free in the club common areas. However, horses can run free in any arena provided the owner is present and no one is prevented from using the arena. The Jump Arena may not be used on days with inclement weather.
- 13. Stalls must be clearly marked with horse's name and an emergency contact number.
- 14. The Barn is in no way responsible for the behavior of horses in the pastures. Contact the Vice President for any matters that concern the pastures.
- 15. When horses are in pastures or stalls there must be a usable halter and lead in close proximity.

 a. Halters must be removed when horses are in pastures or stalls.
 - a. b. If a halter must be left on, only "breakaway" halters may be used.
- 16. For use of sick pad and isolation area, make arrangement with the Vice President. In cases where the VP is not available make arrangements with any board member. Sick pad and isolation must be cleaned of all muck on a daily basis.
- 17. All immunizations, coggins, and worming must be kept current and in accordance with the Base Veterinarian and SGRC requirements.
- 18. Horse owners are responsible for cleaning up after their horse(s) at the wash rack, tack lines, farrier shed, barn aisles and "common areas." This includes but not limited to the cleaning up of muck, hoof clippings/shavings and horse hair from grooming/bathing.
- 19. No forms of feed in pastures. No feeding of hay or grain at the tack lines, wash rack or in the round pen. Treats are allowed at the tack lines, was rack and in the round pen as long as any scraps are picked up by the owner.

- 20. If round bales are used, all hay not consumed must be picked up and properly disposed of.
- 21. Stalls must be cleaned on a daily basis after turning your horse out and before you leave the property. Also, if horses are in stalls for a 24-hour period the stalls need to be cleaned both am and pm. "Cleaning" means removal of all manure and urine from the interior of the stall. All stalls will be maintained with an adequate amount of shavings so that urine is absorbed sufficiently.
- 22. Clean up after yourself and your family. Place all trash in receptacles.
- 23. NO bicycles, tricycles, bike trailers or scooters allowed past Barn 1.
- 24. Farriers, Vets, Massage Therapist or Chiropractors work must be completed in the "Farrier Shed". For the health and welfare of the horses, services can be performed in the assigned stall or in the club's sick pad, if available. In case of inclement weather where wind is a factor or the "Farrier shed" is flooded, services may be performed in barn 1 in front of The Club Office. Inclement weather refers to severe or harsh weather that is cold, windy and wet. Barn entrances are not to be blocked by Veterinarian or Farrier vehicles.
- 25. Horse owners are responsible for checking on horses on a daily basis; refer to Article III of the SGRC Bylaws.
- 26. The SGRC tractors are to be used for club purposes only. Members are not allowed to use the tractors for personal use or gain such as but not limited to feeding, grooming and bringing tack to their trailer or horses. Operators must have a valid driver's license. Members must be trained to operate tractors prior to using. EB member must sign off that the training has been completed.
- 27. The Commanding Officer's policy states that all riders aboard the installation of Camp Lejeune MUST wear an equine approved helmet when riding a horse.
- 28. SGRC will comply with applicable fire and safety regulations, environmental laws, local, state, and Federal tax codes, and any other applicable statutes or regulation.
- 29. SGRC volunteers whom have contact with children under the age of 18 must submit to a background check, to be paid for by the SGRC. SGRC will share the results of all adverse background checks with MCCS.
- 30. All members will store equine food, supplements, additives and medications of any kind in a nuisance animal proof container as in accordance with the guidance of the Base Game Warden and/or Base Wildlife Management Offices respectively. All equine food supplements, additives, and medications will be stored in the designated feed rooms only.
- 31. The use of stall guards will be permitted for all horses, in all barns. If a horse is a repeat offender of getting out of their stall with the stall guard in place, this privilege will be revoked. If a horse shows aggressive behavior to human/s or any animal, with their stall guard, this privilege will be revoked. The Executive Board will be the final decision maker for stall guard privileges.

- 32. Members are responsible for complete pasture care in their assigned pastures, to include but not limited to fencing, posts, holes, dragging, and mowing.
- 33. When leaving town or in the event of an emergency member is required to advise the EB and fill out a form with who is responsible for horse(s) while they are away to include an in case of emergency plan.
- 34. There will be 4 mandatory work days and a fee of \$50 each day missed will be charged to any member that does not make a minimum of 3 days without making alternative arrangements with the head of maintenance. (\$50 for 2 days missed, \$100 for 3 days missed, and \$150 for 4 days missed)
- 35. Members are required to purchase rubber stall mats. Mats to be placed in stall no later then 10 days after arrival prior to horse(s) leaving quarentine.
